# **StrokeNet Trial Updates**



ARCADIA is picking up steam!

There are currently 34 subjects consented, 13 eligible for randomization, and 10 randomized. Thus far, then, about 38% of patients with ESUS are eligible, which is consistent with (if slightly higher than) our initial estimates. About half of the patients meet eligibility through the EKG

criterion (increased P wave terminal force in lead V1) and about half through the NTproBNP criterion; severe left atrial enlargement on echocardiography is a rare finding to date.

Study site start-up is also picking up. Thirty-four sites are enrolling (of a target of 120), while 95 sites have their protocol trial agreements and 55 sites have Central IRB approval. Our experience thus far suggests that the biggest impediment to achieving our numbers faster is a lag in getting regulatory and administrative documents (like contracts and IRB) through. Once sites are up and recruiting, they are finding the recruitment to be feasible and relatively easy. We encourage all ARCADIA sites that have not yet started recruiting to redouble their efforts to work with administrators to finalize documents so we can increase our numbers.
