### **StrokeNet Trial Updates**



#### Looking forward to ISC ARCADIA presentations and posters next month!

As of January 30, 2020, 1581 subjects have been consented and 406 participants randomized at 97 sites. This is an increase of 34 consented and 9 subjects randomized during the last two few weeks of January. Our enrollment is at 36.9% of the overall goal.

Thank you to the 30 sites that consented and 9 sites that randomized subjects in the last two weeks. A special congratulations to the University of New Mexico Hospital and the Mayo Jacksonville teams for randomizing their first subjects! You helped us reach and now surpass the 400<sup>th</sup> randomization!

Enrollment has been going strong at the top enrolling sites: United Hospital has 15 randomizations, University of Minnesota Medical Center Hospital has 14, the University of Cincinnati which has 13 and Emory has been gaining ground with 12 randomizations. Thank you all for your dedication and leadership! We need everyone to keep enrolling and follow their example to make ARCADIA a success.

We have now released to enroll a total of 140 sites, 132 are active, and we are still working on adding other qualified sites to the ARCADIA roster. Please let us know of any excellent stroke sites that are interested in participating in this important trial.

Please keep approaching ESUS patients about the ARCADIA trial at your sites. Remember, every site's best effort is necessary for the trial to succeed!

#### Don't forget these important reminders:

- 1. <u>All components</u> of the 3- and 6-month outcome assessments should be conducted by a **blinded** study team member.
- Please use the informed consent checklist at the time any new subject is enrolled. This checklist was sent by email to participating sites on 1/16/2020 and is available on our website: <a href="https://www.nihstrokenet.org/sleep-smart-trial/research-team">https://www.nihstrokenet.org/sleep-smart-trial/research-team</a>. This will help avoid consent errors.
   Common errors include: misuse of an LAR, lack of a witness when needed, use of non-IRB-stamped consent, consent conducted by personnel not listed on DOA.
- 3. Please remember to enter all subjects who meet criteria for enrollment, but decline participation, into WebDCU under Study Progress tab > Screen Failure Report.
- 4. Please remember to report AEs. If you need guidance, please refer to the Sleep SMART MOP. Please recall that the only AEs that should be reported between consent and randomization are:
  - All SAEs (fatal and non-fatal) that are definitely related or stand a reasonable possibility to be related to the Nox T3 sleep apnea test or the aCPAP run-in night procedures (within 5 days of awareness of event for non-fatal; within 24 hours of awareness for fatal)
  - All non-serious AEs of special interest (see protocol 8.3.8) that are definitely related or stand a
    reasonable possibility to be related to the Nox T3 sleep apnea test or the aCPAP run-in night
    procedures (within 5 days of awareness of event)
  - Primary outcome events (ischemic stroke, ACS, and deaths) (within 5 days of awareness of event)
- All responses to Data Clarification Requests (DCRs) must be submitted within 5 days of query generation, except those associated with Serious Adverse Events, which must be answered within 24 hours of query generation. Site payments are contingent upon the subject's data being entered, submitted, and all DCRs addressed.
- Please review the Data Collection Guidelines for Sleep SMART located in project documents in WebDCU for how to complete CRFs. This should be the first place you look when you are not sure how to complete a form.
- 7. If the window for the 3-month visit ends and you have not been able to reach a subject, please continue to reach out to them until the 6-month window begins.
- 8. Don't forget to collect the IQCODE. This assessment should not be done by the patient. It should be completed by someone close to the subject.
- 9. The baseline NIH Stroke Scale should be done after the subject is enrolled.
- 10. All required people documents, including training, will need to be completed and uploaded in WebDCU before your site can be released to enroll. Please continue to work diligently with your study teams to complete the required tasks.

We are up to **130** patients, **37%** of our target, and have begun to accumulate 1-year follow up scans. Let's keep the enrollment going!

#### **ENROLLMENT TIPS:**


Discuss CREST-H during the CREST-2 enrollment process. Patients love to hear about cognition and the possibility of obtaining more information about brain blood flow (and the extra \$100 to participate doesn't hurt). Consent for CREST-H can be signed **on the day of randomization into CREST-2**. Otherwise you can get **verbal** consent to participate in CREST-H during the CREST-2 enrollment, schedule the CREST-H perfusion scan (**MRP** or **CTP**), and have the patient sign the consent when they arrive for their appointment at the scanner.

Recruitment: CREST-2 needs StrokeNet. Our recruitment milestone is 1700 by February 29, 2020. We need 77 patients with 22 days left to go. Please see below the graph that depicts January enrollments for the last 3 years – a worrisome trend.



The Clinical Coordinating Center will be sending a survey out to all CREST-2 coordinators to get a better idea of recruitment challenges at your site. We strongly encourage your participation and feedback... and **we need some new enrollment tactics** that will further the success of CREST-2. Please keep an eye out for an email from Dr. Brott regarding this survey.



SATURN is very excited to continue study start-up! Several sites have both fully executed CTAs and cIRB approval and are being scheduled for Readiness calls beginning in February 2020.

Regulatory documents that required site action were due to be returned and uploaded to WebDCU by January 24<sup>th</sup> 2020. Please address any outstanding regulatory documents at your sites as soon as possible.

RCC coordinators should follow up on all outstanding CTAs at this time. It is important to get your sites ready for release to enroll! We anticipate enrollment to begin March 2020.

SATURN and ASPIRE are having a joint Investigator Meeting! Save the date to go out soon!

Many study documents are posted on the WebDCU toolbox including regulatory documents, training materials, DRAFT CRFs and protocol appendices. Please remind your sites to utilize this valuable study resource.

### **Updated Grant Application Instructions and Forms Coming in Spring 2020**

NIH will require the use of updated application forms and instructions (FORMS-F) for due dates on or after May 25, 2020 (NOT-OD-20-026). A preview of form changes and clarification of how the changes impact research training grant, fellowship, and career development award applications (NOT-OD-20-033) are already available. Additional details will be posted early next year.

In the meantime, continue to use FORMS-E application packages for due dates on or before May 24, 2020 despite the expiration dates noted on each form. The NINDS is working with the Office of Management and

Budget to renew forms and new expiration dates will be reflected when the FORMS-F application packages are posted.

### What to Do if a Due Date Falls on a Weekend or NIH Holiday?

With the winter season upon us, remember that when a due date falls on a weekend, Federal holiday, or when Washington, D.C.-area Federal offices close (due to severe weather, for example), the application deadline is automatically **extended to the next business day**.

If you suspect Federal offices in D.C. are closed due to severe weather you can check OPM.gov to verify. Only when Federal offices in the Washington, D.C. area are listed as "Operating Status: CLOSED" is the application deadline automatically extended to the next day. See NIH Guide Notice NOT-OD-17-041 for additional details.

If your local winter weather is severe and results in the closure of your institution, then NIH submission policies regarding weather/other disasters apply.
